### Elective Courses a.y. 2026-2027 (recommended choices) PANIERE CURRICULUM ACCOUNTING FOR INTERNATIONAL BUSINESS (AIB)

#### GENERAL RULES

In the ELECTIVE COURSES ('SL' - Scelta Libera) section, students may include courses/activities offered at the University and/or Language Learning Activities (AAL) offered by the University Language Centre (Centro Linguistico di Ateneo - CLA), **provided they are consistent with their study plan.**

Specifically, students may not select free choice activities that are **similar or equivalent** to one another, or whose content is already covered, even partially, by courses included in their Study Plan (PdS).

#### PANIERE (ELECTIVE COURSES RECOMMENDED)

Each year, the Degree Programme Board (Consiglio di Corso di Studio - CCS) publishes a list of activities whose consistency with the degree programme has been verified in advance (PANIERE).

Electives selected from this PANIERE are automatically approved without requiring any justification.

The PANIERE defined by the CCS includes:

- 'Choose between' course ("A scelta tra") from the first and second year (if not already selected)
- Recommended course units in the study plan during their year of activation
- Other course units recognized as consistent with the degree programme
- Language courses offered by the (Centro Linguistico di Ateneo - CLA)

#### ELECTIVE COURSES EXTRA-PANIERE

Students may request the CCS, with written justification, to include an extra-paniere activity as a free choice elective or as an extra-credit course in their Study Plan, in compliance with the general rules outlined in this document.

The CCS will evaluate the student's reasoning, the consistency of the choice, and compliance with general rules before approving or rejecting the request.
